

STRAIGHT PARTY

If you desire to vote a straight party ticket for all state, congressional, legislative, and county offices, complete the arrow to the RIGHT of the party of your choice. A straight party vote cannot be cast for Independent candidates. To vote for individual candidates of your choice, complete the arrow to the RIGHT of the name of the candidate. When voting for governor and lieutenant governor, you may vote only for the candidates on one ticket jointly or by writing in the names of persons on the lines provided and connecting the arrow.
